

# Educational Service Unit 11

ESU 11 is an intermediate agency providing supplementary educational services to K-12 school districts in the following counties: Phelps, Gosper, Franklin, Harlan, Kearney, Frontier and Furnas.

## Staff Development

The Staff Development department provides consultative assistance to individual schools in the area of staff development. The department works cooperatively with individual schools to initiate, plan, coordinate, and support staff development activities and programs.

## Gifted Education

High Ability Learner Education (HAL) Services are provided to member schools. The director of HAL provides consultant services for program development, teacher inservice, identification, and student activities. Unit wide opportunities such as Summer Honors, Quiz Bowls, Future Problem Solving, Invention Convention, etc. are provided.

## Technology

The Technology department provides internet access, web hosting, email hosting, new server recommendation/setup/troubleshooting, Local Area Network Analysis and consultations, virus prevention, internet filtering, overall management of the Wide Area Network, and Universal Service Fund consultation and application submission on behalf of schools.

## Technology/Curriculum

This department works with member schools to assist them with the utilization, proper use, and integration of technology into their schools and curricula, both on-site and indirectly through local, regional and state workshops, programs, and activities.

## Media

The Media department provides an array of services to include an Audio/Video/DVD Library (10,000 plus items for checkout), video streaming, teacher work center (die cuts & Cricut machines), laminating, copy reproduction, large format printing, ID badge printing, booklet binding, satellite services, Video/CD/DVD duplication, and equipment loan services (Starlab, Data/Video Projectors, Astronomy Telescopes, RealCare babies, Student Response Systems, video conferencing devices and other associated equipment).

## Special Education

### *School Psychology*

School Psychologists provide assessment and evaluation for students birth to age 21 who have been referred for special education. Consultation and inservice to school district personnel and parents is also an important role in the services to school districts.

### *Occupational Therapy*

Occupational Therapists provide related services to children birth to age 21 who qualify according to the student's individual education plan. Support is also given to students, families and school personnel to enhance the child's education and foster independence.

### *Speech/Language Pathology*

Speech Language Pathologists provide services to children who qualify for special services in the areas of speech communication, language, voice and fluency. Assessment and consultation services are additional services available.

### *Transition*

Transition services and activities provide appropriate vocational assessments, job shadow and extended work experiences, student workshops, business and industry tours, parent workshops, staff development, and inter-agency collaboration and support.

### *Early Childhood Education*

Early Childhood special educators, speech pathologists, occupational therapists, paraeducators, and service coordinators work together to address individual needs of children and provide comprehensive services to children birth to age 5 who qualify for special education.

### *Individualized Special Education Program*

The New View School provides educational services to students with disabilities who benefit from individualized instructional programs. Speech, Occupational, and Transition services are offered according to the individual needs of the student.

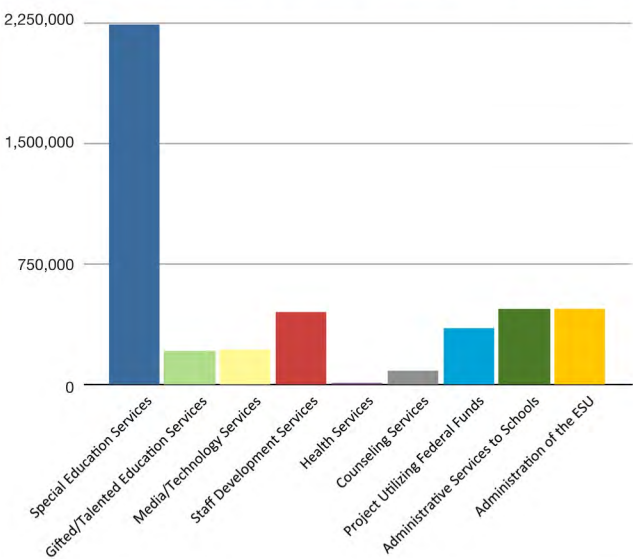

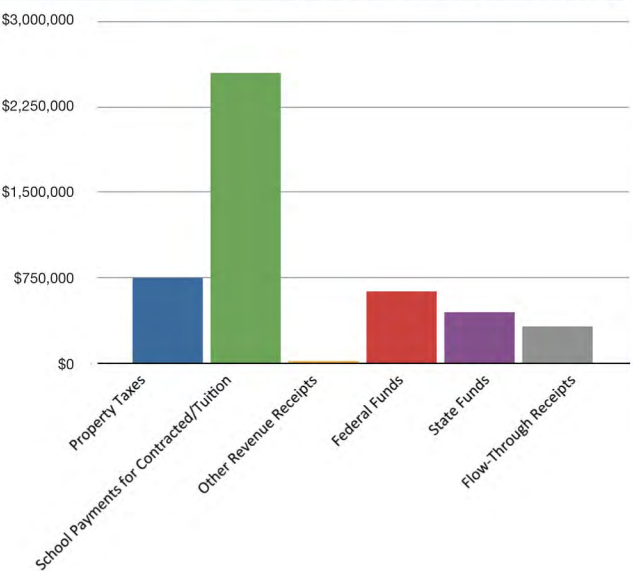


## Revenue Received September 1, 2010 to August 31, 2011

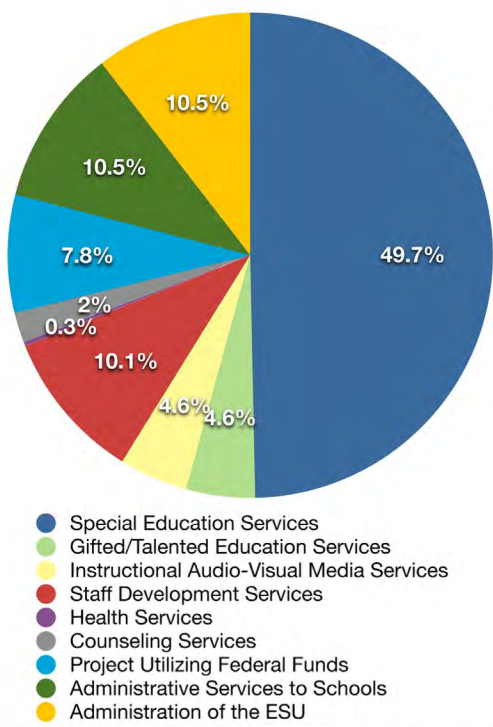

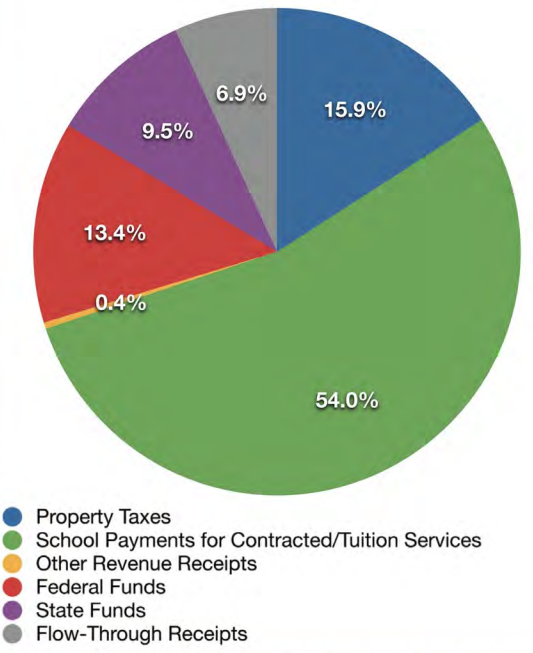

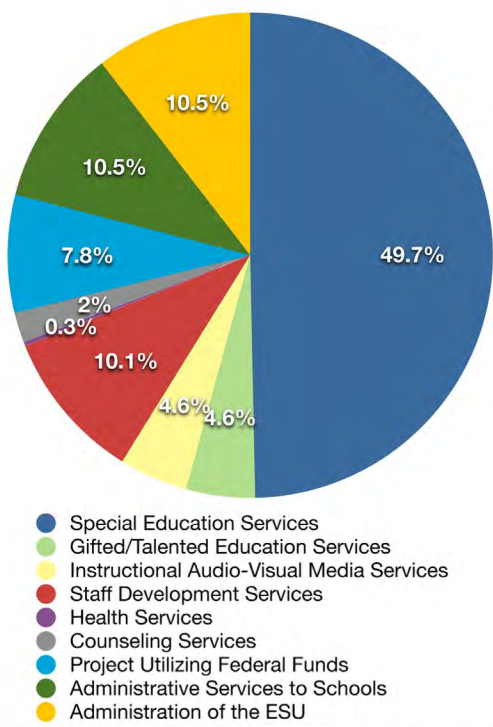
