A total of 49 students attended and toured Midway Chrysler Dodge Jeep Ram, IntelliCom, CMH Interiors, and Chief Agri/Industrial Division. Lunch was had at the UNK campus so students could gain an understanding of eating on a college campus. The Post-School Outcomes Data for the 2013-2014 school year have been reported and the state of Nebraska met all three-target area goals. Lona informed the Board that she has been asked by NDE to attend the Building Capacity Institute for the second year in North Carolina on May 3rd through May 5th.

Alex Wyatt, Technology Consultant, reported that wireless points were extended to the Axtell football field in time for the latest track meet. A new server has been installed at Bertrand and quotes were sent to Dr. Dennis Shipp. Alex noted that Eustis-Farnam have been discussing a new antivirus program and is currently waiting approval for the E-Rate project. The ESU technology department is also helping Holdrege district schools in preparation for the Summer Honors Program starting on June 12th. A new Ag building is being constructed in Wilcox with wireless connectivity to be installed in the near future. ESU 11 has purchased new laptops for SPED staff to replace aging models. Wade and Alex are considering a new mobile device management (MDM) solution for iPads, as the current free Meraki service has become increasingly crippled and the paid version is quite pricey.

Paul Tedesco, Unit Administrator, reported on behalf of Janelle Jack, Gifted Education Coordinator, the school nomination numbers for the Summer Honors Program between the 2015 and 2016 program years. Paul also noted the Nebraska Gifted Programs have struggled to receive adequate state funding for the past few years.

Paul Tedesco, Unit Administrator, updated the Board about the recent Leadership Team Retreat. At the retreat, Leadership members discussed the Annual Survey results, department goals, staffing, and recent interviews for the Speech Language Pathologist opening.
