

**MINUTES OF THE ESU #11 BOARD MEETING

Wade Gibson, Media Technology Coordinator, and Kate Hatch, Staff Development Director, presented to the Board the new Microsoft HoloLens mixed reality headsets that were recently purchased. Microsoft HoloLens is the first self-contained, holographic computer, enabling you to engage with your digital content and interact with holograms in the world around you. Mixed reality brings people, places, and objects from your physical and digital worlds together. A live demonstration was performed of the HoloAnatomy app and then Board members were given a chance to experience the HoloLens themselves. Special thanks to Stephanie Dannehl and Bertrand Community School for loaning four of their HoloLens units to have more available for the demonstration.

Janelle Jack, High Ability Learner Coordinator, talked about the Rural School Activity that her department had recently hosted with the museum. One hundred fifty-three students participated in the activity during the two-week time span. She is scheduled and active in many of the schools. A number of the districts are choosing to work with Crime Scene Investigation, and she is hoping that means there will be a lot of FBI agents in our future. Janelle is working on getting the activities all ready for the PLCs that are coming up, and looking forward to being more visible in the schools through that activity. The department is also working on Give2Grow, which will be November 15. She has had much success with the program in the past, and is looking for another great year.

Dr. Barnes, Unit Administrator, updated the Board on the ESUCC meetings held on September 5 and 6. Dr. Barnes and the district Superintendents would like to bring KSB School Law to the area for a SPED workshop with board members in late January or early February. The workshop would be a great opportunity to educate board members about all laws public schools deal with today. Last, Dr. Barnes reported that the State Auditors would be at the ESU October 22-25.
