Public Notice that the Board of ESU #11 would hold a Public Budget Hearing at 7:00 p.m. on September 18, 2023 was published in the following newspapers of general circulation in the ESU #11 service area during the week of September 4, 2023: Franklin County Chronicle, Harlan County Journal, Holdrege Daily Citizen, Minden Courier, and Valley Voice. The Public Notice included a statement of the purpose of the Public Hearing and a summary of the proposed budgetary requirements for the 2023-2024 fiscal year.

Board Vice President, Galen Kronhofman, stated that the Public Budget Hearing was being held for the purpose of hearing support, opposition, criticism, suggestions or observations of taxpayers relative to the proposed General Fund and to consider amendments relative thereto.
